16 **DELIBERATIONS**

26 **Our key tasks:**

27 ***Policies.*** Coming up with policies that will reduce inequalities

28 ***Concrete acts*** that can help to reduce inequality. Bringing ideas on how to reduce inequality.

29 ***Writings.*** Write research papers that will help in reducing inequalities.

30 These can be summarised into: **Entrepreneurial programmes** and **research works** that will
31 help in reducing inequalities.

32 Mr. Owolabi called these Academic responsibility and Community development. We have
33 the artisans and the unemployed. Also, through skill acquisition programmes, we can take
34 pictures from there.

35 Dr. Asamu identified areas of inequalities to include economic inequality, social inequality
36 and ecological inequality.

95 **OPENING PRAYER**

96 The meeting commenced at 10.08am and the opening prayer was said by Mr. Ahmed.

97 **INTRODUCTION OF NEW MEMBERS**

98 One new member introduced himself:

100 **READING OF LAST MINUTES**

101 The Secretary read the Minutes of the last meeting held on the 28th July, 2020.

102 **ADOPTION OF LAST MINUTES**

103 Dr. Rasak moved the motion for the adoption of last Minutes and seconded by Mr. Ahmed
104 subject to minor corrections.

105 **MATTERS ARISING**

106 The first matter arising from the last Minutes concerns members who Have not been attending
107 meetings. Despite series of meetings, it was discovered that there are still two people (out of
108 the list of members sent from LUCRID) who have never attended the meeting. Group members
109 who might meet those people were therefore enjoined to invite them for our meetings.

110 The second matter arising was on how to populate our stand. The coordinator emphasised the
111 need for more ideas on how to populate our stand because only infinitesimal number had
112 responded to the call.

113 It was also noted that our social media platform is too silent. It was noted that it seemed only
114 one person sends messages. The coordinator solicited for our participation by commenting on
115 any messages that are sent or at least send relevant messages that portray inequalities.

118 **AGENDA**

119 The coordinator solicited for reports from both the research groups and group committee that
120 were formed. Reports from research subgroups were first received before that of the
121 entrepreneurial activities.

122 **Research subgroups**

123 Only one group was able to present its proposal, and other two groups assured that their
124 proposals would be presented in the next meeting. The coordinator commended members of
125 the group that presented and encouraged other group members to borrow a leaf from them and
126 follow suit in next meeting (that will be held in two weeks' time).

127 The coordinator went on to suggest that more topics should be worked upon and presented by
128 each group to accommodate more topics for all four members. However, some others stated
129 that whatever each group decides should be the final. Due to contrary opinion, the group agreed
130 that each research group should work only on the accepted topics and such topics should be
131 ready for presentation in the next meeting. In other words, each research group should continue
132 to work on their proposals (based on the accepted topics) and they are expected to present them
133 on the 3rd September, 2020.

134 **Subgroups on entrepreneurial activities**

135 Mr. Oyeyipo represented the Awareness Committee and stated that there will be need to first
136 ask people about their views or perspectives of the concept of inequality. This will be achieved
137 by visiting people in their shops, *et cetera*. It was further suggested that posters can be placed
138 in strategic places to create awareness on inequality.

139 The Education Committee, represented by Mr. Oyekola and Mr. Adebisi, stated that the group
140 aimed at focusing on secondary school students and teach them on how they can bridge
141 inequality gap. The group also proposed a short clip or documentary that will preach 'leave no
142 one behind' and begins to disseminate such knowledge through social media. The coordinator
143 suggested that the group document these ideas such that it will get to the point of being
144 executed.

145 The Skill Acquisition Committee stated that they could not meet as a result of other cogent
146 meetings. The coordinator encouraged the subgroup members to prepare adequately against
147 next meeting.

148 **AOB**

149 The coordinator anticipated that our group might be called to have a virtual presentation to the
150 University community. A member also confirmed this trend that every webinar is connected to
151 at least three SDGs.

152 For those that are not in any subgroup or committee, it was resolved that they should meet with
153 the Secretary to see which group will fit them more.

154 The coordinator appreciated everyone for making it to this meeting and encouraged everyone
155 to get to work.

156 It was suggested that the next meeting will come up next two weeks, Thursday, 3rd September,
157 2020.

186 **READING OF LAST MINUTES**

187 The Secretary read the Minutes of the last meeting held on the 20th August, 2020.

188 **ADOPTION OF LAST MINUTES**

189 Dr. Rasak moved the motion for the adoption of last Minutes and seconded by Mr. Oyeyipo
190 subject to minor corrections.

191 **MATTERS ARISING**

192 The first matter arising was how to populate our stand as it was still an issue that all of us need
193 to take very seriously. The coordinator therefore solicited for members' support to achieve this
194 goal.

195 **AGENDA**

196 The first was on Grant that was sent to us by the Director, Landmark University Centre for
197 Research, Innovation and Discovery (DLUCRID). The coordinator identified Gupta as a
198 promising grant but discovered that it wasn't meant for academic but majorly for NGOs.
199 Another grant was also deliberated upon and it was noted that all of us were qualified for the
200 grant.

201 Next on the agenda was research subgroups, and the coordinator requested the groups,
202 especially those who had not made their presentations, to present their proposals. The research

203 group two first made her presentation on ‘Coping strategies of street beggars during covid-19
204 total lockdown in some selected states in North-Central Nigeria’ and constructive criticisms
205 were received. Suggestions on how to improve the quality of the proposal were also received.
206 Afterward, research group three presented her proposal on ‘Parental involvement and students’
207 perceptions of teachers as determinants of academic achievement among senior secondary
208 school. Students in selected local government areas in Kwara State’. Constructive criticisms
209 were provided for quality improvement. Finally, the coordinator appreciated everyone for
210 ensuring that their proposals were ready.

211 On the possibility of receiving aid from the LUCRID to conduct our research, the group agreed
212 that we should be ready on our own part to collect data using our resources and then hope that
213 the school will pay for it. On the meantime, we should submit our proposals to LUCRID as a
214 way that we are working. Consequently, issues on how to finance data collection was raised
215 and whether we should make collective contribution or individual contribution (base on
216 subgroups) was deliberated. It was resolved that collective contribution should be made. Base
217 on this, each subgroup was encouraged to bring considerate cost analysis in next meeting.

218 Considering the increasing number of members, another group was created with the aim of
219 ensuring more commitment on the part of everyone. The new group members include Dr.
220 Ogunlade, Dr. Arisukwu, and Mr. Olubukoye.

221 A suggestion was raised whether to relax committee’s responsibilities in order to focus more
222 on research proposals. However, it was considered imperative to drive all agendas
223 simultaneously: Publications, community service and population of stand.

224 On reports from the three committees, Awareness Committee promised to make their
225 presentations. Members of Skill Acquisition Committee estimated their cost to be ₦50,000.
226 Also, Education Committee presented a cost estimate of ₦50,000 (for editing) with a proposal
227 of making a short clip that will be made available to students on YouTube platform, *et cetera*.
228 However, the group noted that if someone can help in editing this, there would be no need of
229 cost implication.

230 **AOB**

231 Item 7 was suggested and the Coordinator made provision for it. In addition, the Coordinator
232 appreciated everyone for making it to the meeting.

233 **MOTION FOR ADJOURNMENT**

234 Mr. Olubukoye moved the motion for adjournment while Mr. Owolabi seconded the motion.

268 **OPENING PRAYER**

269 The meeting commenced at 2.20pm and the opening prayer was said by Dr. Ogunlade.

270 **READING OF LAST MINUTES**

271 The Secretary read the Minutes of the last meeting held on the 3rd September, 2020.

272 **ADOPTION OF LAST MINUTES**

273 Mr. Oyeyipo moved the motion for the adoption of last Minutes and seconded by Dr.
274 Ogadimma subject to minor corrections.

275 **MATTERS ARISING**

276 The first matter was still on how to populate our stand.

277 The second was on grant. The coordinator took the pain to visit DLUCRID and Dr. Dunsu for
278 clarification on already sent grant and they replied that we would be intimated on suitable grant.

279 Reports from subgroups and committees was another mater arising from the meeting. The
280 coordinator first appreciated every Group and Committee for their efforts so far. Dr. Ogunlade
281 was informed about his admission to newly created group (4).

282 The first group made her presentation by proxy. According to the group, 200 copies of a
283 questionnaire will amount to 4,000. Also, Transportation will cost 6,000 making a total of
284 10,000. The cost of

285 Group two proposed the printing of 2 pages of a questionnaire, to be administered to 400
286 respondents amounting to ₦3000. Tonner for ₦1500. Transport will cost ₦2000. Total is
287 ₦6,500. Also, 200 will be giving to 30 participants bringing it to ₦6,000. The grand total cost
288 of data collection will be ₦12,500. Transportation was changed to be ₦4,000. Totalling 14,500

289 Subgroup three proposed of going to five different places and the cost of transportation is
290 ₦20,000. Research assistant in each location to be visited will collect ₦2,000 for 5 people
291 totalling ₦10,000. For the questionnaire, ₦3,600 will go for two realms of papers and the
292 printing will cost ₦2,500. Miscellaneous expenses is taken to be ₦4,000. Coding and analysis
293 will be ₦25,000. The grand total is 65,100. The total cost was however reduced to ₦17,000.
294 The cost from group three raised many issues which brought about some many other
295 resolutions.

296 Group four stated that topic is still being deliberated in the area of unequal access to
297 government job, how people get government job and the second area is access to justice.

298 The three committees were requested to present their reports. The awareness committee
299 brought a proposal to produce Bill board and flyers of A5 size which will cost ₦6,500 for 100
300 copies. The bill board will collect 14,000 for printing and welding of iron is 30,000. The cost
301 transportation is 5000. The subgroup said they will go to town the following day and bring
302 reports of whatever they get from community members. That will determine what will be
303 written on the billboard. It was suggested that the committee should do the needful and follow
304 due protocol.

305 Education committee had already presented her proposal which was estimated for ₦50,000.

306 The skill acquisition committee presented her budget by proxy. Ingredients cost 10,000.
307 Facilitator 10,000. Refreshment 20000 for 100 people. Totally ₦40,000.

308 The coordinator encouraged all subgroups to submit their proposals in black and white latest
309 Monday, 17th September, 2020.

310 The coordinator divided the total cost of research proposal (₦41,500) among active members
311 (those whose name will appear on the paper) and each member is expected to pay 2600 to be
312 paid latest month end. In the meantime, group four is expected to present their proposal so as
313 to add it up to already presented proposals.

314 **MOTION FOR ADJOURNMENT**

315 Dr. Ogadimma moved the motion for adjournment while Dr. Ogunlade seconded the motion.

352 **READING OF LAST MINUTES**

353 The Secretary read the Minutes of the last meeting held on the 17th September, 2020.

354 **ADOPTION OF LAST MINUTES**

355 No adoption because there was no network to download minutes for thorough check.

356 **MATTERS ARISING**

357 The coordinator stated that the proposals presented in our last meetings have been submitted
358 to LUCRID.

359 Only sub-group four proposal has not been submitted to LUCRID because they are yet to
360 submit to the Group.

361 Concerning the update on payment of data collection, the Financial Manager stated that 13
362 people have paid while only three people are yet to make their payments. The coordinator went
363 further to state that papers and tonners have been purchased.

364 The coordinator requested for reports from sub-group 4 and the leader responded that they have
365 made progress so far and that network delayed the submission. He also gave the excuse that
366 although the group members are somehow old, they will surely submit their proposals in due

367 time. The coordinator stated that by next week, we should be collecting data and be ready to
368 submit those papers to Scopus indexed journals.

369 Next on the Agenda was on the outcome of the SDG meeting with the vice chancellor and
370 director, LUCRID. According to the coordinator, the University is ready to sponsor SDGs
371 researches. Hence, the management requested between 5 and 10 research topics to DLUCRID.
372 The coordinator then sought for advice on how to generate more topics. Consequently, it was
373 suggested that since every group has been requested to work on at least 4 research topics, we
374 only need to go to our archive and dig out topics to be worked upon. Summarily, since we have
375 4 groups, each group was asked to bring at least 2 research topics which will be at least 8 topics
376 to be submitted to DLUCRID.

377 The coordinator then encouraged group leaders to quickly summon urgent meetings for topics
378 generation. Although group two had some topics on ground, they planned to present it in the
379 next meeting. Group four requested for one or two weeks to bring their topics. The coordinator
380 however stated that time is not on our side, rather, the topics should be ready as soon as
381 possible. After thorough deliberations, it was agreed that each group should submit their topics
382 on or before Thursday, 22nd October, 2020 and then continue with writing the proposal for the
383 next two weeks.

384 The coordinator appreciated everyone for accepting the challenge and assure group members
385 that we shall run with the vision.

387 For community development, once the University is ready to sponsor, we shall implement the
388 proposal.

432 The meeting commenced at 10.am and the opening prayer was said by Mrs Osueke.

433 **INTRODUCTION OF NEW MEMBERS**

434 The following new members were introduced:

436 **INTRODUCTION OF NEW SECRETARY**

437 The coordinator notified the house that new Secretary has been appointed in person of Mr.
438 Oyeyipo, although without any explanation.

439 **INTRODUCTION**

440 The coordinator appreciated everyone. She further stressed the need to be committed to this
441 SDG and stated that everything we do here is still to our benefits. She informed that VC called
442 for a meeting and that call influenced the drive we are experiencing in our group.

443 **READING OF LAST MINUTES**

444 The Secretary read the Minutes of the last meeting held on the 16th October, 2020.

445 **ADOPTION OF LAST MINUTES**

446 Mr. Oyeyipo moved the motion for the adoption of last Minutes and seconded by Dr. Mrs. Ake
447 subject to minor corrections.

448 **MATTERS ARISING**

449 On reports from VC's meeting with the 17 SDGs, all SDGs were grouped into 4 and the one
450 that concerns us as to do with Recreation Centre. Fortunately, majority of the SDG leader in
451 the group (Recreation Centre) are still from this SDG. The coordinator said there will be a call
452 to all the concerned SDG leaders.

453 Clarification on the THE ranking according to university ranking and SDG was deliberated and
454 it was resolved that the VC/LUCRID will be in better position to clarify that.

455 It was suggested that external professional should certify the safety/security of the dam before
456 any construction will take place.

457 On authors affiliations, it was emphasised that all authors, both individual and group, should
458 henceforth bear two affiliations: Department and SDGs.

459 On the report from the group contributions. Each one contributed N2,500 and only three people
460 are yet to pay.

461 The Financial manager stated that only subgroup one had printed their instruments. What
462 remains is ₦31,500. When the instrument was given to the group, it was returned until when
463 they will be ready to administer the instrument. Particularly, it was noted that the examination
464 pressure caused the delay experienced.

465 The group one said their own instrument was ready but have not been submitted. The
466 coordinator however encouraged the group to submit to appropriate quarter for onward
467 processing.

468 It was noticed that Mr. Tunde had not been coming for the group meeting.

469 Group two also claimed that their quantitative instrument was ready, but remains minor
470 correction on the qualitative instrument.

471 The coordinator encouraged all subgroups to submit all instruments to Mr. Oyeyipo. The
472 Coordinator stated that all instruments must have been administered and returned before 12th
473 February, 2021.

474 As we were discussing, Mr. Tunde entered and declared his intention to continue his
475 membership of SDG 10.

476 Observation was raised on the group using Secondary School Students as their subjects. The
477 Coordinator encouraged the group to ensure that their instruments is ready for distribution once
478 the schools resume.

479 On the issue of Concept Note, the Coordinator encouraged everyone to do the needful. As a
480 result, the coordinator appealed to every member of subgroup to briefly meet for maximum of
481 30 minutes and come up with their concept notes for onward processing. After each group met,
482 the coordinator appreciated everyone and requested every group to forward same to the
483 Secretary's email for collation.

484 **MOTION FOR ADJOURNMENT**

485 Mr. Tunde moved the motion for adjournment while Dr. Mrs. Iwelumor seconded the motion.

587 The meeting commenced at 1.06pm and the opening prayer was given by Mr. Ahmed.

593 **READING OF LAST MINUTES**

594 The secretary read the minutes of the last meeting held on the 17th July, 2020.

595 **ADOPTION OF LAST MINUTES**

596 Mr. Ahmed moved the motion for the adoption of last minutes, subject to minor corrections.

597 **MATTERS ARISING**

598 The first matter arising from the last minutes is how to populate our stand. It was noted that the
599 SDG inauguration was imminent and therefore, there was need to populate our stand. In that
600 line, some pictures (such as short and tall person, someone wearing rag and another wearing
601 good cloth, someone wearing a very beautiful shoe and another wearing one 'god-help' shoe,
602 a disable person, people living in slum, old women on the street, among others) were presented
603 for further evaluation. Pictures of Orphanages were also suggested.

604 The second matter arising from the last minutes was the reports from the three sub-groups.
605 Group two, represented by Mrs. Osueke, was called. The group mentioned the need to first
606 create awareness at the community level through programme organisation. Second, the group
607 saw the need to teach people how to manage their time. It is believed that by managing time,
608 the vulnerable can be able to make money that will help in reducing inequality. Third, the group
609 talked about skill acquisition such as how to make soap (both liquid and detergent), zobo, body
610 cream, among others. In addition to entrepreneurial activities, group two members also
611 highlighted some research topics that SDG 10 group can explore and these topics include:

612 ‘Assessment of government programmes (such as N-Power, Market women money, and trader
613 money, among others) toward reducing inequalities’; ‘Coping strategies of street beggars
614 during covid-19 total lockdown in Omu-Aran community’; and ‘Effects of Covid-19 on
615 vulnerable groups: Toward realization or utopianization of SDG 10 in rural Nigeria’.

616 Group one, represented by Dr. Mrs. Dada, was called upon to present the outcome of its
617 subgroup meeting. The group focused on the area of education, as members of the group saw
618 education as a major factor in increasing or reducing inequality. If community members can be
619 given proper education, the group maintained, inequalities will be reduced. The group went on
620 to mention two research topics that could be conducted and these include: ‘Socio-demographic
621 factors and parental involvement in educational activities of children in Omu-Aran
622 community’; and ‘Home factors and economic performance of secondary school students’.

623 Group three, represented by Dr. Rasak, started by stating that cost was a major determinant in
624 every decision taken. The group emphasised that the skill acquisition to be embarked upon
625 must have very high patronage and the target could be unemployed youths. The group
626 identified three possible skill acquisitions. One is **Catherine Services** and it was cost to be
627 about one hundred and sixty-seven thousand naira (₦167,000). The second was soap making
628 (costing ₦20,000 per person as a start-up capital for empowerment) and tie and dye. The group
629 mentioned that raising capital for the participant is crucial at this time. Furthermore, the group
630 highlighted two research topics to include: ‘Rural women empowerment, a panacea to poverty
631 alleviation in Irepodun local government’; and Impact of market women money on poverty
632 reduction and the challenges militating against the success of the programme’.

633 The third matter arising from the last minutes was how to populate our stand. The coordinator
634 said pictorial image that depict inequality is expected from everyone.

635 **COMMENTS ON THE REPORTS**

636 On awareness creation, it was deliberated that we need to examine those community issues that
637 we may use to enter the community. Hence, the group that suggested this idea was saddled
638 with the responsibility of knowing what the problems in the community are. Workshop to teach
639 time management was considered appropriate, but linked with skill acquisition. Target group
640 for skill acquisition were identified to be the vulnerable and how to get them was discussed
641 such as in churches and mosques, as well as through community leaders. Lastly, Campus
642 cleaners were identified as our first target. The following research **topics were agreed upon:**

- 643 1. Assessment of government programmes (such as N-Power, Market women money,
644 and trader money, among others) toward reducing inequalities
- 645 2. Coping strategies of street beggars during covid-19 total lockdown in Omu-Aran
646 community
- 647 3. Socio-demographic factors and parental involvement in educational activities of
648 children in Omu-Aran community
- 649 4. Home factors and economic performance of secondary school students
- 650 5. Rural women empowerment: A panacea to reducing inequality in Irepodun local
651 government’
- 652 6. Impact of market women money on poverty reduction and the challenges militating
653 against the success of the programme’.

654 **COMMITTEES ON ENTREPRENEURIAL ACTIVITIES**

655 In order to develop viable proposal for entrepreneurial activities particularly awareness
656 creation, skill acquisition and educational development, it was resolved that three committees
657 should be inaugurated comprising all members. The division of the SDG 10 group into
